

MOBIL HOME OR CHALET BOOKING GENERAL CONDITIONS

1/Any rental is restricted to the customer and may in no case be transferred or sub-let.

Rental only comes into force following our agreement and after receipt of a sum:

- Equal to 30% of the total cost of the stay(deducted from final total)

- Plus 15 €uros for administrative expenses (payable to the campsite and NOT REFUNDABLE) Rental applications must run for a period of at least one week in July and August. Each week starts at 15h00 on Saturday. The balance of the stay is payable the day on arrival. No reductions will be made for late arrival or early departure.

2/ CANCELLATION

In the event of cancellation administrative expenses will either be due or deducted from any refund.

- Booking fees

As compensation for breach of contract

- a sum equal to 30% of the total cost of the stay will be due if you cancel the stay more than 30 days before the scheduled date of arrival

- a sum equal to the total cost of your stay if you cancel less than 30 days before the scheduled date of arrival or if you fail to show on that date.

3/ NON OCCUPATION/LATE ARRIVAL

In the absence of the message (letter or fax) explaining that the date of arrival has been deferred, the rental will be made available 24 hours after the date of arrival stipulated in the rental contract and full payment of all services will be required. We can not accept telephone messages as valid proof of late arrival.

4/ DEPOSIT

a) you will be asked to make a deposit of 300€ or 500€ on the day of arrival to cover equipment and rental cleaning and upkeep costs. It will be returned to you after the inventory (between 8,00 and 11,00) if the inventory reveals damage or undue wear and tear the campsite will retain the deposit and an invoice will be issued 50,00€ for cleaning and 450,€ for damage.

The inventory will be done up on the last day of the stay between 8,00 and 11,00 if the inventory cannot be done up because the customer has left before the agreed time the campsite will retain the deposit and return it by post, after drawing up an inventory with the owner subject to possible deduction of any expenses (cleaning, damage)

b) Campsite user must take out insurance. The campsite can accept no responsibility in the event of theft, fire, bad weather* etc. nor with respect to the civil liability of the user.

The campsite is closed at 23h00 to 7h30, all traffic is forbidden during closing hours.

The campsite only accepts dogs or other pets on condition they are kept strictly on a lead.. DOGS 1 and 2 categories not accepted

6/ CAMPSITE REGULATION

The customer acknowledges that he or she has read the campsite regulations and agrees to comply with their requirements.

Shorts are forbidden in the swimming pool trunks are compulsory

The rental agreement will only come into force after reception of payment of the request advance and written confirmation from the management of the campsite

Any disputes shall be ruled under french law. In the event of a disagreement of interpretation between the provisions of the present agreement and any translation that may be made in other language, french version shall prevail.

PITCH BOOKING GENERAL CONDITIONS

1/ The full cost of the stay booked at the campsite must be paid on the day of arrival

2/ If for whatsoever reason the period of your stay is cut short the total cost of the stay remains due to the campsite.

3/ The booked pitch will be available from 14 h onwards and its occupation must end of the last day of rental at 12 . Do not forget to bring personal ID to the office

4/ For late arrivals, if with the campsite management as not been informed a charge equivalent to the basic rate for two people will be made for each day of no-occupation

5/CANCELLATION

In the event of cancellation administrative expenses will either be due or deducted for any refund.

-booking fees

-A sum of 85€ will be due if you cancel more than 30 days before the scheduled date of arrival

- A sum equal to the total cost of your stay will be due if you cancel less than 30 days before the scheduled date of arrival or if you fail to show on the date.

6/ NON OCCUPATION/LATE ARRIVAL

In the absence of the message (letter or fax) explaining that the date arrival has been deferred, the rental will be made available 24 hours after the date of arrival stipulated in the rental contract and full payment of all services will be required. We cannot accept telephone messages as valid proof of late arrival.

7/ Booking is considered as final on reception of the advance. Any rental is restricted to the customer and can only be transferred to other persons subject to another contact.

8/ The campsite only accepts dog or other pets on condition they are kept strictly on a lead DOGS 1 and 2 categories not accepted

9/ The campsite is closed from 23,00 to 7,30 All forms of traffic are forbidden during closing hours

10/ Shorts are forbidden in the swimming pool trunks are compulsory

11/ we only allow 1 vehicle per pitch
